- Secretary to call for Nominations for Sub-Committees and Appointed Officials to be with Secretary by Sunday 11 May 2025 to distribute with May CoM Agenda papers.

Thursday 10 April 2025

Secretary to call for Notice of Motion of Special Business to be with Secretary by Sunday 11 May 2025.

Tuesday 15 April 2025:

- Secretary to call for Nominations for CoM by 60 days prior to AGM – *Rule 24.3 (a)* to be with Secretary by Sunday 11 May 2024 for distribution with AGM papers 35 days prior to AGM
- Regional nominations for Croquet Victoria Life Membership due 60 days prior to AGM – *Rule 7(a)*.

Sunday 11 May 2025

Saturday 17 May 2025

Secretary to distribute Notice (& Agenda) of 2025 Annual General Meeting, 28 days* prior - *Rule 15.1*.

By 10.30 am Monday 26 May 2025

Regions to notify Croquet Victoria Secretary of their Regional Director – 21 days prior to AGM - *Rule 23.3(c)*.

Thursday 5 June 2025

Secretary to distribute Notice (and Agenda) of June 2025 Council Meeting 7 days* prior.

By 10.30 am Saturday 14 June 2025

Notification of Regional Delegates to AGM to Secretary 48 hours before meeting – *Rule 12.2*.

*The requirement is for 28- or 7-days' clear notice – neither the day of notification nor the day of the meeting can be counted in the number of days' notice.
