Dear colleagues

Our election timetable reminds us that now is the time to start thinking about nominations for Council positions, including office-bearers, Committee of Management members and Regional Directors. The attachment lists the positions which are continuing and those that are due for appointment in June 2026.

This is **on the basis of our current constitution**, which as you know is under review. Progress to date has involved suspension of regular Committee of Management meetings (previously held every two months). Council is currently meeting monthly from February to December. Directors have discussed this arrangement and agree that it has been working well. It will continue in 2026, with the constitution working group going on to consider other possible improvements in our governance arrangements.

We are assuming that the current constitution will still be in force at the time of the June 2026 elections.

In line with our Mandatory Board Quota procedure, I need to draw your attention to the gender balance on Council.

We are committed to having at least 40% women Directors. Currently we are going well on this. 58% of our Directors are women: 11 women out of 19 Directors.

However, in June the total number of Directors could change. Three Regional Directors also have a position on the Committee of Management. Two of these positions are due for election this year – if other members are elected, the total membership of Council will be 21. To achieve 40% membership would require Council to include 9 women.

- Six women Directors hold positions which do not expire till 2027.
- So three women need to be elected or appointed in the 2026 round for us to be sure of achieving the 40% ratio this year.

Please could you discuss this when you are considering nominations / appointments?
