## Annex A to Croquet Victoria Council Meeting Minutes 20 October 2025

#### **FINANCIAL REPORT SEPTEMBER 2025**

The following financial reports are attached:

- Summary Profit and loss for six months ended 30 September 2025 against prior year and budget
- Balance Sheet as at 30 September 2025
- JBWere Monthly report Summary September 2025

#### Key points to note:

The Net Operating result at the end of September is \$318,152 compared to budget of \$52,863 and \$123,003 last year. The overall result, including positive Investment market movement, is \$674,041 compared to budget of \$97,863 and \$211,934 this time last year.

#### Income

- a) The JB Were investment portfolio income YTD is \$338,499, compared to budget of \$127k and \$146,419 last year. As reported previously, JBWere has paid us a remediation amount of \$160,498. This is in addition to Trust Income this year being significantly higher than budget and last year.
- b) VCA Affiliation fees are \$5k below budget. There are still some final adjustments which should come through in October, including for Brimbank Club, which reduce most of this shortfall.
- c) The unrealised gain on the Investment portfolio YTD is \$355,889 continuing to be much higher than expected given market uncertainty.

#### **Expenses**

- a) MYOB and Admin support and Committees continue to be lower than budget.
- b) The first payment from the Development Initiatives Fund was made during the month to Drysdale Croquet Club.
- c) Differences in other expenses are mainly due to timing.

#### **Balance Sheet**

- d) Net Assets at 30 September were \$10,116,526 compared to \$9,490,409 at September last year. The movement in Net Assets for the six months is an increase of \$674,041.
- e) Accounts Receivable is mainly affiliation fees still outstanding.
- f) See attachment for summary pages of the JB Were portfolio at 30 September showing the value of \$6,282,247 an increase of \$673k since the end of March.
- g) GST net payable reflects GST on Affiliation fees.

#### **Cash Outlook**

The operating bank account is \$67k at month end. There is no foreseeable need to draw any amounts from the Investment portfolio in the next couple of months.

#### Other

The Finance sub-committee has not met since the last Finance report.

## President's report

## **Under 21 Coordinator report**

#### **BACKGROUND**

The task of the State Coordinator of Under 21 Croquet is to create and deliver a state program aimed at people under the age of 21 that will encourage, nurture and develop players in the sport of croquet. This paper provides a brief update on events since my last report.

#### UPDATE

### 1. Current Under 21 membership and support

Currently fourteen affiliated members from nine clubs have been registered as aged under 21, plus there is at least one affiliated junior who has not been registered as under 21.

According to this year's annual club survey, clubs in every region are engaging with schools. Thirty-one clubs reported that they were definitely running a schools program this year, and thirteen said they plan to do so. The Child Safe sub-committee plans to contact these clubs and check how they are going.

## 2. Coaching activity

On the first Saturday of the September holidays, all our under 21 players were invited to participate in a Croquet Day Out at the Victorian Croquet Centre. The number registering was low. In the end three 17 year old members participated, from three widely dispersed clubs. They played doubles with some more experienced players and singles against each other. Many thanks to all the players who contributed to this. Despite the low numbers it was a positive and enjoyable event.

#### 3. National events

There have recently been some changes in the suite of national Under 21 events as from January 2026. Some of the changes that were initially announced have now been modified following feedback from Croquet Victoria members and their parents. The upshot is that:

- Croquet Australia has suspended the national Under 21 Gold and Silver Medal competition, which means that state Bronze competitions will no longer be required. Croquet Victoria's Bronze will be re-badged as a State Under 21 Singles Championship.
- The national Under 21 Doubles will run if there are sufficient entries. I have advised families
  of this.
- The dates of the national Under 21 events next January have been amended to fit within the window of the previously advertised Under 21 Singles. This means that families that have already booked travel and accommodation will not need to change their bookings.

## 4. Victorian Under 21 Championship, Saturday/Sunday 6/7 December

I hope that this will attract enough participants to warrant a two-day event. If not we may organise some additional activities on the Sunday, and invite non-members to participate.

#### 5. Support for Under 21 Coordinator

I would particularly like to thank Graham Smith who has been actively contacting clubs and families and providing support for juniors.

#### REPORT - Child Safe Sub Committee - From Russell Worland

The Sub Committee convened on October 7<sup>th</sup> and would advise as follows;

- 1. The Convenor (pro tem) is Kate Patrick. This will be reviewed early in 2026
- 2. The Secretary is Russell Worland
- 3. The Terms of Reference of the Child Safe Sub Committee (CSSC) were reviewed. Council last approved the Terms of Reference in early 2025. The Sub Committee seeks amendment as follows being the inclusion of a new clause being Clause 11 requiring that the CSSC report to Council after each meeting of the CSSC
- 4. The Terms of Reference set the minimum membership of the CSSC at 4 persons. Current membership is 3 persons (Kate Patrick, Joan Loorham, Russell Worland). Graham Smith is to be invited to nominate to the Sub Committee
- 5. The work program of the CSSC is to be developed over October and November with consultation to be discussed with the Secretary CV and details to be furnished to the December meeting of Council.

# Constitution Review Working Group - Update on Progress October 2025

## 1. The Structural Experiment

20 October 2025

At its meeting on 24 February 2025, the Working Group (WG) considered that an experimental organisational reform might be implemented before embarking on any work to amend the constitution. The idea is:

- Council meetings to be held monthly
- Committee of Management meetings suspended

This would enable Council members to directly assess how Croquet Victoria (CV) might operate without a Committee of Management, while not requiring any formal changes to the constitution. After a period (say, six months), the WG could solicit feedback, assess, and develop possible constitutional changes for Council review.

The experiment is designed to determine whether abolition of the Committee of Management, with monthly meetings of the Council, would be an effective solution for the primary constitutional and governance issues identified by the WG and endorsed by Council: inefficiency because of overlap / duplication and the disempowering of Council, which is, constitutionally, the prime decision making body of CV.

The concept was reviewed by the March meeting of the Committee of Management and the April meeting of Council. It is currently being implemented.

The WG is now of the view that a review should be undertaken in the next quarter, once another CoM / Council cycle is completed, and requests that Directors:

- (a) Reflect on how the experimental structure is working in order to provide considered feedback when the review is undertaken
- (b) Consider what criteria should be used for evaluation in the review and send any thoughts through to the WG

#### 2. Other Working Groupm Activities

The WG has been considering the Charter and Code of Conduct and has concluded that further work on the Charter should only be undertaken once the two key structural issues are resolved ie CoM / Council and Federation of Regions vs Federation of Clubs.

There are currently two different Codes of Conduct in Croquet Australia (CA) documentation. The WG intends to clarify whether the objective of CA is to have a single Code of Coduct, if so which one, and whether CV should develop its own Code or adopt the CA Code of Conduct.

Once the CoM / Council review is completed work will focus on the Regions / Clubs issue.

Wimmera Region Report October 2025

The Wimmera has now been reduced to just 2 clubs, Dimboola and Horsham with Casterton now just playing social croquet amongst themselves. I believe the two younger competitive players have moved to Portland.

Wimmera continues to hold annual singles and doubles championships, and the pennant season is currently underway, 4 teams from Horsham and one from Dimboola. There is also an Autumn mixed competition held from April to May which is more of a social event. Teams are a combination of Horsham and Dimboola players.

This year Charles Rees stood down as president with Rachel Cousins elected as the incoming president. Donna Frost remains secretary and Robyn Goodwin as Treasurer.

Both Wimmera, Dimboola and Horsham joined the Wimmera Regional Sports Assembly this year, it is a non for profit organisation dedicated to supporting the growth, development and promotion of sport and recreation at the grassroots level in the Wimmera region. They have been helpful in advertising the Horsham Come and Try day held during seniors week, help with self-reporting tax, and have interesting workshops. The Horsham club secretary attended the Child safety session held at the end of September.

#### Dimboola

Dimboola Croquet Club had 26 players at the beginning of the year but has lost 7 players (5 to relocating and 2 passing) at the time of report there are 19 players.

The code played is Golf Croquet.

There are no junior players.

The club is in reasonable financial condition.

The court has been scarified and is in reasonable condition. Maintenance is left to one member (volunteer). The club participated in the soil testing which was on offer and have implemented recommended treatment.

The club has a good relationship with the council, paying no rates.

5 members participated in the TMA workshop run in Horsham and thoroughly enjoyed it

## Horsham Croquet Club October 2025'

This year the club was saddened at the passing of Betty Etherton and Iris Williams and Kevin Geyer who had all been great contributors to croquet, and active in maintaining the club in Horsham.

Horsham currently has 50 members, plus 2 non-playing social members, currently there are no junior players but during third term we do have school children visit as part of their sports program. The Child safety officer has made good inroads into ensuring we respond to the Child safety Standards, some areas to work on but good progress to date/.

This year three members were awarded life memberships, Donna Frost, Lyn Creasey and Jenny Pipkorn who have all contributed greatly to the club. A certificate of appreciation was also given to past member Ella Lister and was celebrated with a lovely afternoon tea and presentation.

Horsham have a core group of members who travel to outside tournaments with some success and enjoy attending them.

Members also had the chance to participate in the TMA workshop which was thoroughly enjoyed with noticeable improvement to play. Many thanks to Maurice and Sarina Cevaal-Hewitt. The club continues to hold practice sessions with drills one Wednesday every month.

The Horsham tournament will be held at the end of October and again filled up very quickly, it is 3 days with doubles, singles and high/low doubles.

Horsham holds 3 regular play days (Golf Croquet), with one day for social play and the other 2 which count towards club aggregate. Alternating every week between level play and handicapped play

The club participates in pennant at this time of year against Dimboola, and a friendly mixed competition in Autumn with Dimboola players

The club is in a good financial position. This year we received a grant from Horsham Sports and community centre that is allowing installation of a sprinkler system on a small patch of lawn between car park and courts lawn to make things easier for members.

Our courts are manged by members and we have regular assessments of our courts by agronomists and they have reported that the courts are in good condition. We have 4 courts but during the tournament we expand and are able to use the tennis courts for 4 extra courts.

The club is situated on crown land, currently we don't have a lease so are limited in regards pursuing upgrades like ensuring toilets are accessible to wheelchairs etc. the council has done some repair work for us, on the building and garden beds.

During the Christmas period we generally have 2 to 3 work groups use the facilities for xmas functions, Horsham provides the equipment and members are there to guide them through how to play, this hopefully broadens the amount of people that are aware of croquet.

The club continues to hold a Come and try day during seniors week, this year advertising supported by the Wimmera Regional Sports Assembly.

# GCA Report to Croquet Victoria Council Meeting to be held on Monday, 20/10/25 by Zoom

The Geelong Croquet Association covers five clubs - Belmont, Colac, Drysdale, Eastern Park and Queenscliff totalling 255 members - this is approximately 10% increase to last year and not including the 25 unaffiliated QCC Social Members.

Most members play Golf Croquet with a small percentage of Belmont, Eastern Park and Colac members playing Association Croquet. As per last year, there is currently no active promotion to raise awareness or participation by any club. Adding to the mix, unfortunately Ricochet is losing interest with last social play day actually being cancelled.

The most popular regional events are the GC Social Days - they are well patronised and supported, to the point where local members cannot enter, although member numbers are slowing increasing for competitive play. As referenced earlier, with the increase in club membership and encouragement, this has had a flow-on to increased tournament participation by members - a positive sign for the balance between competitive and social play.

All clubs are active in social media - some more than others. Currently clubs promoting 'Come and Try' Days during the Seniors Festival Month which has a positive effect raising croquet as a sport but effort is still required by some clubs to raise brand awareness within younger demographics.

The region is gearing up to the AC Open to be held on Melbourne Cup Weekend, 1-4/11/25 at Belmont and Eastern Park.

There are still insufficient referees for the area especially for Golf Croquet. Belmont does not have a GC Accredited Coach, however Colin Menzies (Drysdale and Queenscliff member), is making an impact with his Coaching Sessions at Drysdale and Queenscliff, as evidenced in tournament placegetters.

Thank you to Croquet Victoria for the providing soil testing of the lawns and the good advice and decision offered by the Soil Testers to improve and/or maintain the lawns. The Shire of Colac Otway assisted Colac with their lawns which are still having ongoing issues.

Croquet Victoria Heritage Badges were presented to all clubs and region recipients: -Belmont - Robert Shinners; Colac - Ruth Crabbe; Eastern Park - Carmel Terrington; Queenscliff - Ann Drayton; GCA - Eileen Gough Belmont requested and was offered by CV a TMA GC Novice Workshop - 3<sup>rd</sup> Session to be completed on 12-13/11/25 - this workshop was opened to the region and was well attended and received. Special thanks to Kevin Beard and supporting coaches. Eastern Park intend to schedule their TMA AC Development Workshop later in the year.

Colac has received grants from business and community service organisations which have provided them with health and sporting equipment. Drysdale were successful in obtaining funds through the CV Development Initiative Fund.

Life Memberships for 2025-26 were presented by their clubs to Gillian Horvath (Drysdale) and Tony Pye (Eastern Park.

Like most clubs motivating members to take an active role in how their club is run, is an on-going challenge. We are currently looking for a CV Alternate Director.
